

Admission Requirements

Direct Entry

An applicant must have:

- At least five passes obtained at the same sitting of UCE.
- At least two principal passes in any of the subjects done at UACE obtained at the same sitting.

Diploma Holders Entry

An applicant must have

- At least a Second Class- lower Diploma in Law from a recognized Institution.

Degree Holders Entry

An applicant must have

- At least a Second Class lower degree from a recognised Institution.

Mature Age Entry

Applicants must have sat for and passed subject-based Mature Age Entry examinations within the 2 year range.

BACHELOR OF LAWS (LLB)

Duration and Intakes

The programme will take four (4) academic years. Each academic year consists of two semesters. A semester lasts 17 weeks i.e. 2 weeks of a semester will be reserved for final written examinations while the 15 weeks will be for teaching.
